GUARANTEE: Individual reservations makers will provide valid credit card information for each reservation. Each guest is responsible for all fees, including incidental charges, upon check-out.

CANCELLATION POLICY: Any guest room cancelling within 2 days prior to arrival will forfeit one night's room and tax charge as penalty. Any room guaranteed for late arrival that is not utilized by midnight on the day of arrival will also forfeit one night's room rate and tax. These fees are nonrefundable.

CUTOFF DATE: None. This group is under no contract and has no obligation regarding a room block. The hotel will honor the rates as long as rooms are available in the hotel inventory.

HOTEL POLICY: Hotel is a 100% smoke free facility. Any room having an indication that a guest has smoked in it will be assessed a \$100. per day cleaning fee. Rooms may be reserved by guest 21 and older only.

CHECK-IN/OUT TIME: Check-in time is 4 p.m. Check-out time is 11:00 a.m. Departures after 11:00 a.m. will incur a half days room rate, after 12:00 p.m., noon, will incur a full day fee.

PAYMENT METHOD: Payment for guest rooms booked will be the responsibility of each guest and will be settled at departure. The Hotel will authorize one night's room and tax at least 24 hours prior to guest's arrival.

MISCELLANEOUS ITEMS:
